Brief Description of Proposed Action (include purpose or need): The project site is in the Town of Wawayanda, Orange County, New York, on the south side of Dolsontown Road. The property is comprised of tax lots 4-1-50.32, 6-1-107, 90.22 & 90.24, located in the Town's Mixed Commercial zoning district (MC-1). The project proposes a lot line change and lot consolidation to create the proposed lot. The project site totals +/- 20.17 acres in size and has frontage along Dolsontown Road to the north. The parcels are currently mostly undeveloped with a mixture of woodlands and wetlands, and 2 small buildings along Caskey Lane on the east side of the parcel. The site contains approximately 6.45 acres of federal wetlands. As part of the project a minor amount of wetland disturbances are proposed totaling less than 0.09 acres. The applicant proposes to construct a 234,900 S.F. warehouse building with 14,700 S.F. of office space, 173 employee parking spaces, 44 trailer storage spaces and 57 loading docks. Other site improvements associated with this project include water and sewer service connections to existing town mains, stormwater management areas, and associated landscape and lighting improvements.

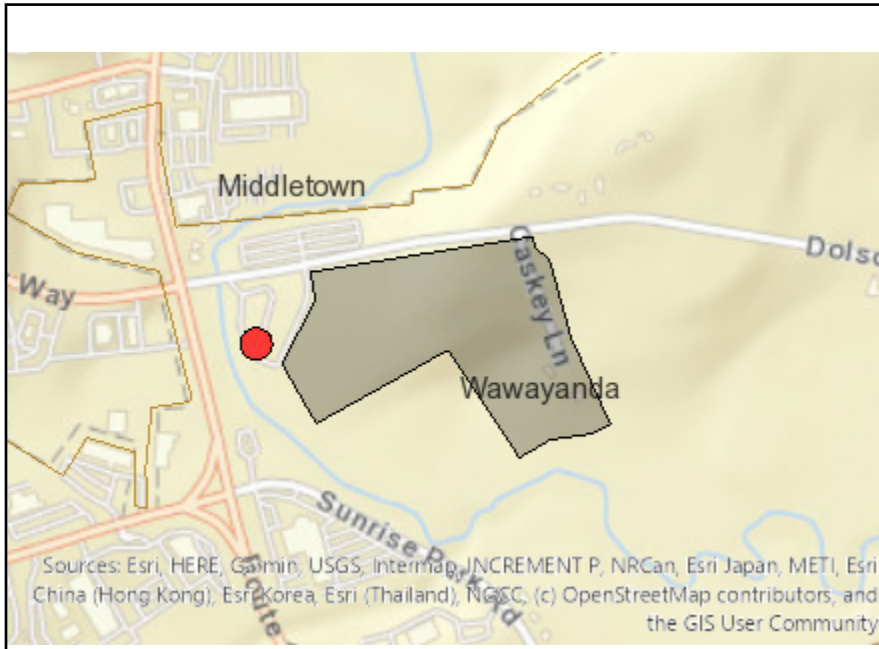
